FI Institutional Global Developed Equity ESG Values Fund (the "Fund") a sub-fund of Fisher Investments Institutional Funds plc (the "Company") Euro 2 Class Shares (unhedged) (IE000GZ4W1Y1)

The Fund is managed by Carne Global Fund Managers (Ireland) Limited (the "Manager"), with Fisher Investments acting as the Fund's investment manager (the "Investment Manager")

OBJECTIVE AND INVESTMENT POLICY

Investment Objective

The investment objective of this actively managed Fund is to outperform the MSCI World ex Fossil Fuels Index (the "Benchmark") on average by 2-6% per annum (gross of fees) over a full market cycle. Neither the Fund nor the Investment Manager guarantees any level of return or risk on investments and there can be no assurance that the investment objective of the Fund will be achieved. The Fund is actively managed by the Investment Manager, meaning that investment decisions are made on a fully discretionary basis. Accordingly, the portfolio holdings may deviate from the Benchmark. This deviation may be material.

Investment Policy

The investment universe of the Fund is primarily determined by the Benchmark. The Fund invests:

- Primarily in equities and equity-related securities of, or linked to, issuers that are included in the countries represented within the Benchmark.
- Up to 20% of its total assets in equities and equity-related securities of companies established in countries not represented within the Benchmark.
- Up to 10% of its total assets in unlisted equities.

While the Fund will invest primarily in equities and equity-related securities, as referred to above, the Fund may for liquidity, hedging and/or

cash management purposes, in circumstances of extreme volatility or if market factors require and if considered appropriate to the investment objective, invest on a short-term basis in cash, cash equivalents, money market instruments or government or corporate bonds. Investments in other funds will not be more than 10% of the Fund's total assets.

The Fund promotes environmental and social characteristics. This includes, the Investment Manager applying a comprehensive set of ESG and socially responsible investing exclusionary screens that are aligned with Catholic values to prevent the Fund from investing in companies that do not meet the Investment Manager's minimum environmental and social considerations. The Fund seeks to promote, the reduction of greenhouse gas emissions, the conduct of business in accordance with international norms, and better health and social cohesion.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

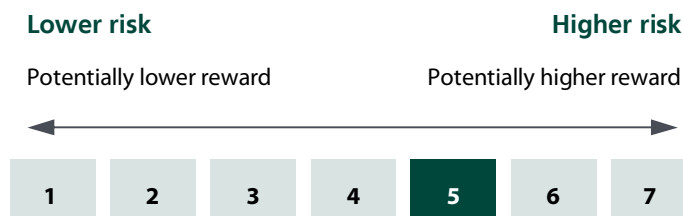

Income

Income from the Fund's investments will not be paid out in dividends.

You can typically sell shares in the Fund on any business day (as set out in the Fund's supplement).

RISK AND REWARD PROFILE



The risk category shows how much the Fund has risen and fallen in the past 5 years, and therefore how much the Fund's returns have varied. It is calculated using historical data and may not be a reliable indicator of the Fund's future risk profile. To the extent this share class has no or limited historical data, Benchmark data is used to supplement such historical data. The risk category is not guaranteed to remain unchanged and may shift over time. The lowest category does not mean risk-free. The Fund is ranked 5 due to its exposure to equity markets, which means the Fund may experience significant volatility.

Currency Risk: The base currency of the Fund is US Dollars. The non-US Dollar share classes of the Fund may be affected unfavourably by fluctuations in currency rates.

Liquidity Risk: Some of the Fund's investments may be difficult to buy or sell. This might affect the price at which the investments can be sold, which would affect the Fund's value.

Counterparty Risk: There is a risk that counterparties to some of the Fund's investments may not perform their obligations and that transactions may not settle.

ESG Risk: The Fund may be subject to regulatory uncertainty and additional costs in implementing ESG regulations and is reliant on ESG data which may not always be accurate or complete. The Fund might underperform relative to comparable funds that do not incorporate ESG factors or pursue a sustainable investment objective.

Catholic Values Investing Risk: The Fund applies exclusionary screens that are aligned with Catholic values and may choose not to purchase, or may sell, otherwise profitable investments in companies which have been identified as being in conflict with the Catholic Values Minimum Standards. This means that the Fund may underperform other similar funds that do not consider alignment with Catholic values when making investment decisions.
